- 1 Subscriptions run for 12 months from the beginning of the month in which membership is taken out.
- 2 Applications for Company Membership cannot, for legal reasons, be accepted from persons under the age of 18. Under 18s will be enrolled as Sandtoft Juniors - a "non-Company" support group for the Museum.
- 3 Additional Family Company Membership can apply only to those additional adults (over 18) resident at the same address. Full membership rights and liabilities apply, but only one Company Journal per issue will be sent to the Company Members at that address; each Junior is entitled to a copy of the Company Journal.
- 4 Gift Aid: You do not have to complete this section, but it will help us financially if you do sign. You can cancel the Gift Aid Declaration at any time by notifying Sandtoft Transport Centre Limited. You must pay an amount of UK income tax and/ or capital gains tax at least equal to the tax that we reclaim on your donations in the tax year (currently 28p for each pound you give). If in the future your circumstances change and you no longer pay tax on your income and/ or capital gains equal to the tax that we reclaim, you can cancel your declaration. If you pay tax at the higher rate, you can claim further tax relief in your Self Assessment tax return. If you are unsure whether your donations qualify for Gift Aid tax relief, ask us, or ask your local tax office for leaflet IR113 Gift Aid.
